How to complete your Proxy Form

Appointment of proxy

1. A member entitled to attend and vote at the meeting may appoint a proxy to attend and vote on their behalf.
2. All full and life members have the right to appoint of proxy.
3. A proxy does not have to be a member of the Sport Aircraft Club of S.A. Incorporated.
4. If you wish to appoint the Chairman of the meeting as your proxy, please mark the box to show this appointment. If you wish to appoint another individual as your proxy, please write the full name of that person where indicated on the proxy form.
5. If the appointed proxy (other than the Chairman) is not present at the meeting, the Chairman of the meeting will act as your proxy.
6. If you have not nominated a proxy, the Chairman of the meeting will act as your proxy.

Voting directions to proxy

1. To direct your proxy how to vote, place a mark in one box for each special resolution.
2. If your proxy is left open for a special resolution, your proxy is able to vote as they choose or to abstain from voting on that item.
Please note that if the Chairman of the meeting is your proxy and you do not mark any of the boxes opposite the special resolutions, the Chairman of the meeting intends to vote available proxies in favour of all special resolutions
3. Special resolutions will only be passed if at least 75% of those members eligible to vote and that in fact vote on the resolutions, vote in favour of the resolutions. This therefore does not include members that abstain from voting, either in person or by proxy.

Signing of proxy form

1. A proxy appointment is only valid if the proxy form has been signed by the member making the appointment.
2. If a proxy form is signed under a power of attorney, you must lodge the original or a certified copy of the power of attorney with your proxy form, unless you have previously lodged one of these documents with the Secretary.
